

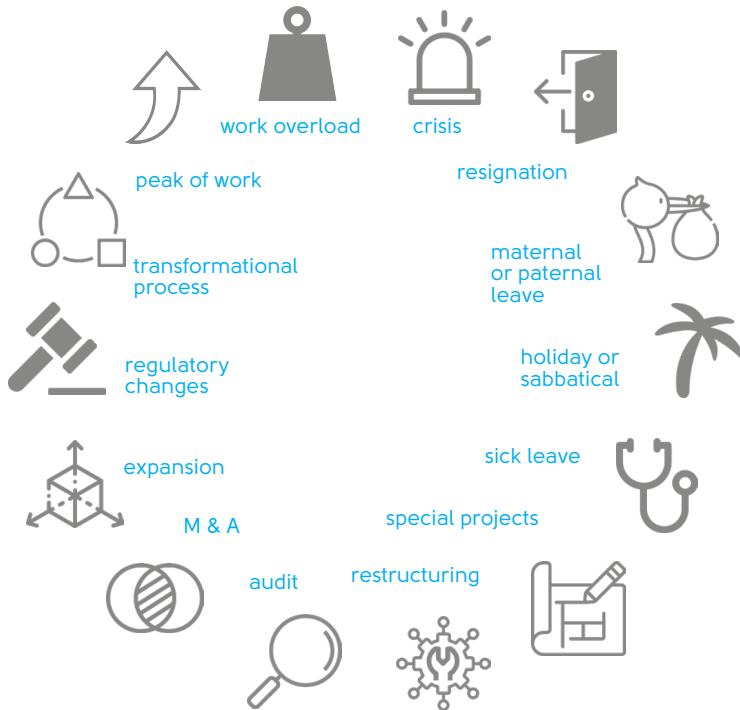

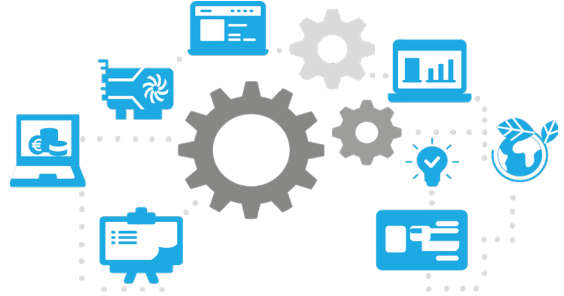
### Our People
